

# **Assistant Research Psychologist/Research Associate**

### Job description

### Job Purpose:

In this role, the Assistant Research Psychologist or Research Associate will carry out research with the aim of improving healthcare for autistic children with intellectual disabilities and their families. The research will primarily focus on delivering and evaluating an anxiety intervention that can be used in clinical settings.

### Main duties and responsibilities

- ► To deliver intervention sessions, following a manualised protocol
- To undertake collection of research data by questionnaire, interview observation, experimentation & formal assessment.
- To carry out administrative tasks associated with specified research projects, e.g. recruitment of participants, preparation of manuscripts for publication, organisation of project meetings and documentation.
- To liaise directly with members of the research team at Aston, Birmingham and Warwick Universities, and attend meetings at these locations (mostly at Aston).
- To liaise directly with charity partners (Autistica & Cerebra) and clinicians working in local NHS Trusts.
- To prioritise and manage tasks within agreed work schedule to ensure that projects are delivered by agreed deadlines.
- To contribute to research grant applications of relevance to the research project (guidance will be provided).
- To contribute to undergraduate and postgraduate research supervision and training.
- To attend meetings and conferences to disseminate research results.
- To be available to participate in fieldwork as required by the specified research project.
- To travel to various locations in the UK to gather data from children, young people, and their families where the ability to travel by road between several locations is essential.
- To complete tasks as outlined by the Principal Investigator and in line with the job grade.

#### Working with volunteer participants

- Liaising with participants and the research team, arranging interview times, explaining procedures, taking informed consent, and showing appropriate care and consideration of families in their homes.
- ▶ Liaising with staff from charity partners and clinical services in recruitment of participants. An awareness of participant confidentiality will be needed. Enhanced DBS will be needed.

### **Data handling**

- Anonymise and code interview data
- ▶ Code questionnaires and video footage and enter data into SPSS format.
- Manage data to ensure data integrity and ease of access to data for the principal and co-investigators.
- Data processing and statistical data analysis.

### Reporting

- Prepare study findings for presentation in study reports and publication in scientific journals
- ▶ Ensure that all work is undertaken and analysed in a timely manner and in line with the milestones and deliverables outlined by the principal investigator. Regular reporting of progress to the team.

### Additional responsibilities

- Engage in continuous personal and professional development in line with the demands of the role, including undertaking relevant training and development activities to develop themselves and support the development of others.
- Ensure and promote the personal health, safety and wellbeing of staff and students.
- Carry out duties in a way which promotes fairness in all matters, and which engenders trust.
- Promote equality of opportunity and support diversity and inclusion as well as working to support the University's environmental sustainability agenda and practices.


